# **ARBITRARY DETENTION AND ARREST**

Throughout the week, prosecutors ordered the detention of at least 77 people over alleged links to the Gülen movement. In October 2020, a UN Working Group on Arbitrary Detention (WGAD) <u>opinion</u> said that widespread or systematic imprisonment of individuals with alleged links to the group may amount to crimes against humanity. Solidarity with OTHERS has compiled a detailed <u>database</u> to monitor the Gülen-linked mass detentions since a failed coup in July 2016.

**November 13:** A Turkish endocrinology and metabolism expert, Professor Cihangir Erem, who was included on Stanford University's World's Top 2% Scientists' List in 2020, 2021 and 2022 <u>serves</u> a sentence on conviction of links to the faith-based Gülen movement.

**November 16:** Nagihan Yavuz, a former cadet serving a life sentence in İstanbul, was <u>hospitalized</u> on Wednesday after fainting in her ward.

**November 17:** Imprisoned for 18 years, Sadık Aslan, whose release was postponed last May "because he mentioned the Constitution", will <u>remain</u> in prison for another 3 months with a new decision of the Administration and Monitoring Board.

## **ENFORCED DISAPPEARANCES**

No news has emerged of <u>Yusuf Bilge Tunc</u>, a former public sector worker who was sacked from his job by a decreelaw during the 2016-2018 state of emergency and who was reported missing as of August 6, 2019, in what appears to be one of the latest cases in a string of suspected <u>enforced disappearance</u> of government critics since 2016.

## FREEDOM OF ASSEMBLY AND ASSOCIATION

**November 18:** The Diyarbakır leg of the march to Gemlik against the isolation of PKK leader Abdullah Öcalan <u>started</u> under police blockade. Citing the governorate's ban, the police detained at least 30 people.

## FREEDOM OF EXPRESSION AND MEDIA

**November 14:** At least 3 news articles mentioning Supreme Court of Appeals member Ömer Faruk Aydıner were <u>blocked</u> from access and ordered to be deleted by Bakırköy 2nd Criminal Judgeship of Peace on the grounds of violation of personal rights.

**November 14:** At least 3 news articles related to the allegation that three members of the Prophet Lovers Platform (PSP), known to be close to Hezbollah, were working as teachers in schools affiliated to the Ministry of National Education were <u>blocked</u> from access by the Diyarbakır 2nd Criminal Judge of Peace.

**November 14:** At least 3 news articles about the explosion at the Tosyalı Iron and Steel Plant of Tosyalı Holding in İskenderun on November 8, 2023, in which 13 workers were injured and 1 worker lost his life, were <u>banned</u> from access and ordered to be deleted by the İskenderun 2nd Criminal Judgeship of Peace on the grounds of violation of personal rights.

**November 15:** Timur Soykan's articles titled "The wheel of bribery is covered up", "The rotting judiciary", "Insulting our intelligence" and "Judge: I received the audio recording of the intervention in the judiciary" and at least 2 news articles were <u>ordered</u> to be deleted by the Istanbul 4th Criminal Judgeship of Peace on the grounds of violation of personal rights. **November 15:** The content of the Engelliweb website dated November 1, 2023 and entitled "Deletion of the news on the sanction of the news on the wheel of corruption in the courthouse, deletion of the news on the deletion of the news on the deletion of the news on the deletion of the news" was <u>ordered</u> to be deleted by the decision of the 4th Criminal Chamber of Peace of Istanbul for violation of human rights.

**November 16:** Workers' Party of Turkey (TİP) Seyhan district chair Hakan Çayan was <u>sentenced</u> to 11 months and 20 days in prison for 'insulting the President'.

**November 17:** The Radio and Television Supreme Council (RTÜK) <u>fined</u> a total of 11 items broadcast on Halk TV, Flash News, KRT, FOX TV, Star TV and Show TV.

**November 17:** Upon The Radio and Television Supreme Council (RTÜK)'s request, Deutsche Welle's dwturkce.com and inspiredminds.de domains were <u>blocked</u> from access by the Ankara 9th Criminal Judgeship of Peace on the grounds that it had not obtained the necessary license.

#### **FREEDOM OF RELIGION**

**November 15:** According to a recent report by the United States Commission on International Religious Freedom (USCIRF), Alevis <u>were</u> the religious community that suffered the most attacks on religious property in Turkey between 2003 and 2022.

## **JUDICIAL INDEPENDENCE & RULE OF LAW**

**November 13:** An İstanbul court <u>ruled</u> to release six of 36 defendants who are standing trial due to their connection to a terrorist attack in İstanbul last year that left six people dead.

**November 14:** The European Court of Human Rights (ECtHR) <u>ruled</u> that Turkish authorities' monitoring and recording of three applicants' meetings with their lawyers while they were in pretrial detention violated their right to respect for private life, ordering the government to pay non-pecuniary damages and costs and expenses.

**November 15:** Ogün Samast, the convicted murderer of Turkish-Armenian journalist Hrant Dink, was <u>released</u> on parole.

**November 15:** Notorious Turkish crime boss Alaattin Çakıcı <u>threatened</u> pro-Kurdish Peoples' Equality and Democracy Party (HEDEP) lawmaker and rights advocate Ömer Faruk Gergerlioğlu on social media over his criticism of Devlet Bahçeli, leader of the far-right Nationalist Movement Party (MHP).

#### **KURDISH MINORITY**

**November 16:** Reber Dosky, a Dutch-Kurdish journalist, producer and director, was <u>detained</u> on November 8 in Turkey, where he had arrived for a new project, and deported after being taken to the Repatriation Center (GGM) in Urfa.

#### **PRISON CONDITIONS**

**November 14:** prisoners with diabetes in Ankara Sincan High Security Prison No 1 were not <u>given</u> proper diet food and prisoners were not transferred to hospitals on time.

**November 16:** It was <u>learned</u> that prisoners in Edirne L Type Prison are given water for 1 hour a day.

# **REFUGEES AND MIGRANTS**

**November 13:** An Afghan man who was injured while working in an illegal coal mine in northern Turkey was not <u>taken</u> to a hospital but was beaten to death to prevent the authorities from learning of the activities of the illegal mine.

**November 15:** Turkish border guards <u>shot</u> dead two young men trying to cross into the country from northeast Syria.

## **TORTURE AND ILL-TREATMENT**

**November 14:** İstanbul prosecutors <u>indicted</u> six police officers on charges of torturing three people in their custody in 2022.

**November 14:** The wards of political prisoners in Balıkesir Bandırma T Type Prison No 2 were <u>searched</u> at 03.00 at night and personal belongings of prisoners as well as items they bought from the commissary were seized during the search.

**November 14:** Prisoners in Ankara Sincan High Security Prison No 1 were <u>asked</u> to pay for translation of Kurdish books. **November 15:** Aziz Beyaztaş and Dilber Beyaztaş were <u>subjected</u> to physical violence of a police officer in Eyyübiye district of Şanlıurfa. Aziz Beyaztaş was hit on his head with the butt of a gun and got wounded.
